The intending Bidders/Purchasers are requested to register on portal <https://www.mstcecommerce.com/directlink> <https://www.mstcecommerce.com/auktionhome/ibapi/index.jsp> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/Purchasers have to transfer the EMD amount using online mode in his Global EMD Wallet well in advance before the auction time. Bidder registration, submission & verification of KYC documents and transfer of EMD in wallet must be completed well in advance at least two days before auction date.
