

In a video message, Scorsese said he has every Ray film in his library and returned to them "over and over again", throughout his life. "He is one of the filmmakers whose work I've returned to over and over again over the years throughout my life. Every time I see his films again, like 'Apu Trilogy' or 'Charulata', it is a whole new experience for me. They are the same films but somehow they deepen, beme enriched within the feelings over the ves,"the 79-year-old filmmaker said. TNN
