

# Goa minister Lobo, another MLA quit BJP before polls

**PANAJI:** Goa minister Michael Lobo and lawmaker Pravin Zantye on Monday quit the ruling Bharatiya Janata Party on Monday, taking to four the number of legislators from the party to have quit since December 17 even as the state head into assembly polls on February 14.

Lobo, who is expected to join the Congress, said he was upset with the functioning of the party, especially the manner in which the grassroots-level workers are treated.

A vocal member of chief minister Pramod Sawant's cabinet, Lobo is the third Christian lawmaker after Alina Saldanha and Carlos Almeida to have left the BJP citing changes in the party's functioning following former chief minister Manohar Parrikar's death in 2019. Christians account for a little over 25% of the state's population.

Lobo's departure also indicates unease among the BJP's Christian MLAs especially in the light of attacks on Christians in neighbouring Karnataka that has not gone unnoticed among the state's minority population.

Clergymen have referred to the attacks that took place over Christmas during religious gatherings in Goa.

Lobo said the BJP no longer values the contribution of grassroots workers. "Many came to me to complain. There will be ups and downs in a party but there cannot be a 'lock, stock, and barrel' replacement of workers," Lobo said. "I have been saying this for a long time but nobody was willing to listen. I felt we were sidelined."

Lobo said he is in talks with other political parties but yet to take a decision on his plans.

Lobo's resignation came a day after Congress leader Digambar Kamat said the former was in touch with the party leadership induction into the party. State BJP chief Sadan-

and Shet Tanavade said Lobo's departure would not make any difference to the party. "All this time he was only physically present in the party. We considered him as having left. We did not dismiss him out of deference..."

Jatin Naik, a political analyst, said Lobo's departure will weaken the BJP in the politically-significant Bardez taluka, which sends seven lawmakers to the 40-member state assembly. "The BJP is on the backfoot and with this development, party's ability to win a simple majority on its own is significantly diminished."

Lobo, who represented the Calangute constituency, plans to field his wife from the neighbouring Siolim constituency.

Zantye, a cashew nut baron who represented the Maem constituency, is the son of Harish Zantye, a Congress Member of

Parliament from North Goa from 1991 to 1996. He quit Congress after he was denied a ticket for the 2012 assembly polls and joined the BJP ahead of the 2017 elections.

Zantye said he joined the BJP based on the assurances of Parrikar and that the party is not the same today. He blamed the government's failure to restart mining and providing jobs in his constituency. "I will be joining the Maharashtra Gomantak Party (MGP)," he added. The Congress emerged as the single-largest party in the state in 2017 with 17 seats in the 40-member assembly. But it was unable to form the government. The BJP, which won 13 seats, managed to form the government in with the MGP, the Goa Forward Party (GFP), and two independents. In 2019, 10 Congress lawmakers defected and gave the BJP a comfortable majority in the assembly.

MGP has since quit the BJP-led alliance and has tied up with the Trinamool Congress. The GFP is now a Congress ally. And 26 of the 40 legislators elected in 2017 are no longer with the party on whose ticket they contested.

# Rajnath, Bommai, Nitish, Nadda test positive for Covid

**NEW DELHI:** Amid a marked resurgence of Covid-19 infections across the country, several ministers and political leaders tested positive for the virus on Monday.

Defence minister Rajnath Singh, Bihar chief minister Nitish Kumar and his Karnataka counterpart Basavaraj Bommai, Bharatiya Janata Party J P Nadda and Union minister of state for defence and tourism Ajay Bhatt announced that they had contracted the virus.

In a tweet, Singh said he has "mild symptoms" and is under home quarantine. "I have tested positive for Corona today with mild symptoms. I am under home quarantine. I request everyone who have recently come in my contact to isolate themselves and get tested," Bommai tweeted.

Nadda, meanwhile, urged those who came in his contact recently to get themselves tested for the virus. "I got my Covid-19 test done after witnessing initial symptoms. My report has come positive. I am feeling fine now," he tweeted.

Bhatt tweeted: "I have tested positive for Covid with mild symptoms. Have isolated myself at home." HTC

# No compromise on right to bodily integrity: HC on rape

**NEW DELHI:** The Delhi high court on Monday observed that even though there can be no compromise on the bodily autonomy of a woman, marital rape cannot be treated as a prosecutable offence because of the qualitative difference between a marital and non-marital relationship.

Describing the difference, Justice C Hari Shankar said a marital relationship holds an expectation and also a legal right for reasonable sexual relation from the spouse. "In a marital relationship, there is a qualitative difference. There is an expectation of a conjugal relationship of both parties. When a party gets married, a person has an expectation and to a certain extent, the legal right also to express normal sexual relationship with your partner. Because if it is denied, it can lead to civil consequences and can also lead to divorce," Justice C Hari Shankar said.

He added that qualitative difference has a part to play in the exception that has been added to the Section 375 of IPC.

Exceptions to Section 375 IPC (rape) decriminalises marital rape and mandates that sexual intercourse by a man with his own wife, the wife not being under 15 years of age, is not rape.

The judge, however, clarified that he was neither expressing his final opinion on the petitions nor examining whether marital rape should be punished at this stage.

Justice Shankar, who was hearing a bunch of pleas filed in 2018 seeking to criminalise marital rape, along with Justice Rajiv Shikdher, observed that a non-marital relation, no matter how close, cannot be compared with a marital relationship.

"If the legislature feels that where parties are married, we should not categorize this as rape as it would be categorised in a case where parties are unmarried and the man says I want to have it (sex) then it is a matter of force. You are not exercising any right which is socially or legally in any manner given to you. Here (marriage) the man is exercising what he believes to be the conjugal right," Justice Shankar said.

He emphasised that the offence of rape was punishable with 10 years imprisonment, and the issue of removal of marital rape exemption required serious consideration. "There is no compromise with a woman's right to sexual and bodily integrity. A husband has no business to compel. (But) the court can't ignore what happens when we knock it (marital rape exception) off," Justice Shankar said.

The court was hearing PILs by NGOs RIT Foundation, All India Democratic Women's Association and two individuals who have sought striking down the exception in the law arguing that it discriminated against married women who were sexually assaulted by their husbands.

The judge also expressed his reservations with regard to the use of the term marital rape, saying that every act of rape has to be punished and the repeated use of marital rape to define any form of an unwilling sexual relationship between a husband and a wife was a "pre-decision" (jumping to a conclusion).

"There is no (concept of) marital rape in India... If it is rape marital, non-marital or any kind, it has to be punished. Repeated use of the word, according to me, obfuscates the actual issue," he said.

Advocate Karuna Nundy, appearing for the NGOs, argued that the marital rape exception created an anomaly as it was under-inclusive (not included) and violated the Constitution.

She contended that the exemption violated the right to dignity and sexual autonomy of women, and that there were thousands of victims who approached her clients for protection.

In 2018, the Delhi government, in its response, told the predecessor bench hearing the case - headed by then acting chief Justice Gita Mittal - that wherever a spouse indulged in sexual relations without the willingness of the other, it was already an offence under IPC, and a woman was entitled to refuse sexual relations with her husband under the right to bodily integrity and privacy as per Article 21 (protection of life and personal liberty) of the Constitution.

**CHANDIGARH:** The Punjab and Haryana High Court granted interim bail to Shiromani Akali Dal leader Bikram Singh Majithia on Monday in the NDPS case against him.

The leader's counsel, Damanbir Singh Sobti, said Majithia will join the investigation at 11 am on Wednesday.

"After seeing all the records, the HC gave directions that this is a case where he can join the investigation and when he joins the investigation, he will not be arrested," Sobti told reporters.

The court has fixed January 18 as the next date of hearing in the matter, he said.

The SAD has been alleging that the FIR against Majithia is a result of "political vendetta".

Reacting to the relief granted to Majithia, SAD chief Sukhbir Singh Badal, in a tweet, said "justice prevails", while his wife Harsimrat Kaur Badal said "truth always triumphs, no matter how big the lie is".
