Lata Mangeshkar in hospital with Covid



Legendary singer Lata Mangeshkar has tested positive for Covid-19 with mild symptoms and is undergoing treatment at a city hospital here, her niece said on Tuesday. The 92-year-old veteran, also known as the 'Nightingale of India', was admitted to the ICU of Breach Candy hospital in south Mumbai two days ago. "She is mild Covid positive. Considering her age, doctors advised us that she should be in the ICU because she requires constant care. And we cannot take a chance. As a family, we want the best and want to ensure she has 24x7 care," Mangeshkar's niece Rachna Shah told PTI. "She will be fine. But she is going to take a while because of her age. And also, Covid-19 takes seven days..." she added. Treating physician Dr Pratit Samdani said that the veteran singer has bilateral Covid pneumonia. "We have admitted her in the ICU (ICU) and are closely observing her," Dr Samdani told HT.

Advanced version of BrahMos tested

{ MY INDIA } TO ASSESS VALUE OF TREES CUT

Need local, state-level tree conservation bodies: SC told



The seven-member expert committee set up by the Supreme Court to assess the value of trees cut for development projects on non-forest land has recommended a tree conservation authority be set up at the state and local levels for overseeing compensatory afforestation and to act as custodians of public-owned trees on non-forest land (PTNFL). Submitting a 184-page report to the top court last week, the committee assigned the task of assessing the value of PTNFL said, "Though this Committee favours a cost-based approach, it agrees that a benefit-based approach based on net present value (NPV) criteria is a better way of assessing the value and making developers pay, as is proposed for land-use change. However, a paucity of studies providing information and data impedes its application in the Indian context." It recommended a large-scale national research project to conduct a species-specific tree ecosystem service valuation to arrive at their NPV, considering the same as functions of age, girth-at-breast, height, etc.

Kohli scores 79 in India's 223 all out



Virat Kohli made 79 on his return from a back injury in the only real resistance as India were bowled out for 223 after choosing to bat first in the series-deciding final Test against South Africa. Kohli was the second-to-last wicket to fall for India on the opening day, when South Africa pacer Kagiso Rabada took four wickets and Marco Jansen three. They gave the Proteas the slight advantage in the series finale at Newlands in Cape Town, although the fast bowlers on both sides have been the dominant force in all three matches so far. So, South Africa's batsmen still had a challenge in front of them before the home team could really claim control. Jasprit Bumrah struck before stumps for India to remove South Africa captain Dean Elgar for three. South Africa was 17-1 at the close and 206 runs behind.

US allows import of mangoes from India



The US has approved import of mangoes and pomegranates from India and secured New Delhi's approval to supply of cherries, alfalfa hay, pork and pork products to India, the two governments said in separate statements. The export of Indian mangoes and pomegranates to the US is in accordance with a recent agreement between India's Department of Agriculture & Farmers Welfare and the US Department of Agriculture (USDA) for implementing the "2 Vs 2 Agri market access" issues, the commerce ministry said in a statement. "Under the agreement, India and the US would follow joint protocol on irradiation for India's mango exports and pomegranate exports to the US and import of cherries and Alfalfa hay from the US," it added. The agreement was signed in pursuant to the 12th India-US Trade Policy Forum (TPF) meeting held on November 23, 2021.

Univs scramble to shift exams to online mode

LUCKNOW: Due to a spike in Covid-19 cases, universities, both government and private, are slowly switching to conduct remaining exams in online mode or have deferred them for later dates waiting for the situation to ease.

Following a protest by a large number of students across the state in the recent past, Dr APJ Abdul Kalam Technical University has

decided to conduct practical exams and project work in online mode from January 14 to 23. Earlier, the university faced criticism from students for conducting all the theory papers in offline mode.

AKTU controller of exams, Anurag Tripathi, on Tuesday, has written a letter to all the directors and principals of affiliated colleges in this regard. The letter reads in view of the prevailing Covid situation across the state, the university has decided to hold practical exams and projects online.

In another development, Integral University, Lucknow, postponed all its ongoing end semester examinations, immediately, for the rest of the courses for second-year students and onwards due to a surge in Covid cases in UP and Lucknow. The revised schedule

for the remaining exams will be announced soon.

University of Lucknow is yet to make a decision about its upcoming exams to begin later this month. However, due to Makar Sankranti, which is a public holiday, the university has postponed its January 14 exam to January 27.

'CHARGE SHEET FILED IN 3 FIRS LODGED AGAINST NARSINGHANAND'

NEW DELHI : The National Commission for Women (NCW) on Tuesday said that charge sheets have been filed in all the three FIRs registered against Dasna Devi temple priest Swami Yati Narsinghanand Saraswati in UP for allegedly making derogatory remarks against Hindu women.

A purported video clip of the priest circulating on social media showed him sitting inside the premises of the temple and making obnoxious comments on the relationship of Hindu women with the people of another religion. The NCW held a hearing in the matter on Tuesday in which Uttar Pradesh DGP, ADG Meerut and SSP Ghaziabad were present in the hearing.

"The officials informed Chairperson Rekha Sharma that charge sheet has been filed in all the 3 FIRs against Yati Narsinghanand & the matter is now before court of law," the NCW tweeted.

Winter rain hits crops in many districts, govt assessing loss

LUCKNOW: The incessant winter rain in more than 50 districts (some of which even received hailstorms) in the past one week is believed to have caused widespread loss to crops, especially in Bundelkhand, prompting the government to order assessment and help farmers accordingly.

"We have asked insurance companies to compensate for the loss that insured farmers have suffered as quickly as possible, after receiving representation from the farmers concerned," ACS, agriculture, Devesh Chaturvedi said. "Till Monday, more than 800 claims were received on the portal and insurance companies are disposing of the same even as more claims are coming," he added.

He said the department of revenue was conducting surveys separately in districts and the

government would provide compensation to farmers after the loss assessment reports were received. "The winter rain has, no doubt, destroyed crops like pulses, oilseeds, potato etc but is also understood to be good for the wheat crop," he said.

As per the rainfall status available with the agriculture department, 58 of 75 districts received winter rain at 6.4 mm that is 514.8% of the normal. Chitrakoot, Hamirpur and Lalitpur districts, all in Bundelkhand, received the highest rainfall till January 10. Region-wise also, Bundelkhand has received the highest amount of rainfall, that is, 1456% of the normal. "Pulses and oil seeds are prominent crops of Bundelkhand and these are the worst-hit by winter rain," said an official.

Covid-19: High court to hear only urgent cases

LUCKNOW: The high court administration has decided to list only urgent cases for hearing and defer all other matters due to spurt in Covid-19.

As the high court switched to only virtual mode of hearing from Monday from hybrid mode (offline and online), the court administration has listed its priorities.

It has decided that regular cases will not be listed for hearing till further orders. In Lucknow high court, some cases, including the ongoing hearing of the Hathras case and the petition related with misbehaviour of lawyers with the additional chief judicial magistrate are most likely not to be listed till further orders of the court.

"The high court administration has taken the decision to not list regular cases for hearing. But all cases related with bail orders or anticipatory bail will be listed for hearing," said Rakesh Chaudhary, president, Awadh Bar Association, Lucknow high court.

"Old cases will not be taken up for hearing unless they are



related with release of petitioner who is in custody," he said.

"In case of civil matters, the court has decided to not take up old cases unless urgency application is filed and allowed by the court," added Chaudhary.

"Those civil matters will also be listed for hearing dates of which have already been fixed by the court," said Chaudhary.

The high court administration has issued separate guidelines for district courts.

The high court has ordered that in criminal cases, no adverse order will be passed and no coercive action will be taken in the absence of parties concerned.

"The district judge will ensure minimal entry of court
