1. Quoted rates will be including or excluding GST in price Bid.	The rates are exclusive of GST.
2. Confirm where to place the electric panel and DB required on every floor.	The drawing of same is uploaded on Bank's website as well as e tender website.
3. Confirm flooring wiring is require for all tables.	Yes floor wiring is required for all tables.
4. Confirm about existing furniture	The existing furniture is at site and will be utilized. Kindly inspect the same.
5. Basic cost of Handling to local authorities should be given by the consultant /Project Architect. Local authorities do not deal with the contractor firm	All requisite permission required from Govt Authorities will be sole responsibility of contractor. Beyond this, any local issue will be dealt by contractor only.
6. Working 24 hours including night time will be required as per site location.	As per local guidelines/extant bye laws.
7. Please clarify as Demolition item civil electrical furniture and AC are not given in tender.	Bare site will be provided, hence no requirement of demolition.
8. In partition item, 9mm thick ply for 2 hours fire retardant is not available.	Use 9mm thick fire retardant MR ply. (ISI 5509 Grade)
9. We request Brand and Basic rate of chair.	The Brand and specification of chairs is mentioned in tender. (Page-221)
10. Drawing and size of S S Dining Table and Sofa.	The drawing of same is uploaded on Bank's website as well as e tender website.
11. Brand of AC	As per tender (specified in Makes)
12. AC will be inverter /Non inverter?	As per tender
13. Time of Completion of Project	75 days (Given in Tender)
14. Which type of insulation to be used on copper pipe?	As per tender (Nitrile Rubber- Armaflex/K flex)
15. Existing AC- what works to be done like Gas charging and testing service?	All units will be new as per tender.
16. Copper Pipe Brand?	As per tender (Mandev or Equivalent)
