Permanent Account Number (PAN)/ FORM60 is mandatorily to be obtained while opening of the accounts as per extant Reserve Bank of India Guidelines.

<b>Deemed Officially Valid Documents, In case OVD does not contains current/ updated address. Accounts of Sole Proprietary firms.	<p><b><u>(Any two of the following documents to be obtained)</u></b></p> <ul style="list-style-type: none"> <li>➤ Registration Certificate</li> <li>➤ Certificate/ license issued by the municipal authorities under Shop &amp; Establishment Act,</li> <li>➤ Sales and income tax returns,</li> <li>➤ CST/ VAT/GST Certificate (Provisional/Final),</li> <li>➤ Certificate / registration document issued by Sales Tax / Service Tax / Professional Tax authorities.</li> <li>➤ IEC (Importer Exporter Code) issued to the proprietary concern by the office of DGFT or License/ certificate of practice issued in the name of proprietary concern by any professional body incorporated under statute.</li> <li>➤ Complete Income Tax return (not just the acknowledgement) in the name of Sole Proprietor where the Firm's income is reflected, duly authenticated/ Acknowledged by the Income Tax Authorities.</li> <li>➤ Utility bills such as electricity, water, and landline telephone bills in the name of the proprietary concern.</li> </ul> <p>In case where the branches are satisfied that it is not possible to furnish two such documents from the above list, they would have the discretion to accept only one of those documents as activity proof. <p><b>Account of Political Parties</b></p>	<ul style="list-style-type: none"> <li>➤ Duly signed resolution of the working committee/ managing body as per bye- laws indicating details of the party president/ authorized signatory, tenure etc.</li> <li>➤ PAN of the Political Party</li> <li>➤ Power of Attorney granted to transact on its behalf;</li> <li>➤ Duly authenticated copy of Constitution/ Bye laws of the Party</li> <li>➤ Duly authenticated copy of Registration of Party with election commission</li> <li>➤ Authority letter, on party letter head, from Party president/ Authorized signatory as per Bye-laws for opening of account mentioning address of the State Unit, Title of Account and operating instructions for authorized signatory with attestation of their signature and photograph.</li> <li>➤ Any one of the OVDs and PAN/ FORM60 of the Office bearers / Signatories and persons holding Power of Attorney, if any with his/her photograph in respect of the person holding an Attorney to transact on its behalf;</li> </ul>
