- As of 31st December 2023, Global Business of the bank grew by 10.68% YoY to ₹ 22.95 trillion.
- Global Advances of the bank grew by 13.59% YoY to ₹ 10.49 trillion as of 31st December 2023.
- Global Deposits of the bank grew by 8.34% YoY to ₹ 12.45 trillion as of 31st December 2023.
- The Bank shed Bulk Deposits (including CD) of ₹ 14,285 Crores during the Quarter from a cost optimization perspective, but for which, the Bank's Deposit and Total Business growth would have been higher.
