However, during the period of quarters ended on 30/06/2004, 30/09/2004, 31/03/2005, 31/12/2005, 30/06/2006, 31/12/2006, 30/09/2007 and 30/09/2008, the Board of Directors annulled the forfeiture in respect of 1300, 600, 1800, 100, 100, 400, 400 and 100 Equity Shares respectively and therefore the total forfeited shares now stand at 27,33,500 Equity Shares. Now the said shares have become 1,36,67,500 Equity Shares of Rs. 2/- face value due to split/sub-division in the face value. Hence there is a difference between columns (10 & 11) and (10 & 15).
