A. **REMUNERATION:**

Selection will be based on short listing and/or Written Test and /or Personal Interview and /or Group Discussion.

GUIDELINES FOR SCANNING THE PHOTOGRAPH (4.5cmX3.5cm) & SIGNATURE:

Before applying online, a candidate will be required to have a scanned (digital) image of his/ her photograph and signature as per the specifications given below:-

(i) Photograph Image :-

- > Photograph must be a recent passport style colour picture.
- > Make sure that the picture is in colour, taken against a light coloured, preferably white background.
- Look straight at the camera with a relaxed face.
- > If the picture is taken on a sunny day, have the sun behind you, or place yourself in the shade, so that you are not squinting and there are no harsh shadows.
- If you have to use flash, ensure there's no "red-eye".
- > If you wear glasses make sure that there are no reflections and your eyes can be clearly seen.
- > Caps, hats and dark glasses are not acceptable, religious headwear is allowed but it must not cover your face. > Dimensions 200 x 230 pixels (preferred)
- > Size of the file should be between 20kb 200kb.
