3. The interest free EMD shall be payable through NEFT/RTGS in the account mentioned above.

4. Only buyers holding valid Digital Signature Certificate and Confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction.
5. Bids shall be submitted through online mode only in the format prescribed. The bid form can be downloaded from <http://www.bankeauctions.com>. The last date for submission of EMD & online bid (not below the Reserve Price) is 16.05.2019.
6. The amount of EMD paid by the successful bidder shall be adjusted towards the sale price. The interested bidders may inspect the Property at site on any working day with prior appointment. Bidders can improve their offer in multiple of
