Re: Bank of Baroda - Notice of Strike by AIBEA ,AIBOA, BEFI and AIBOC - Intimation under Regulation 30 of SEBI (LODR) Regulations, 2015.

We have been informed by IBA vide their letter no CIR/HR&IR/Q/2016-17/864 dated 18.08.2016 that they are in receipt of strike notice dated 11.08.2016 and 16.08.2016 given by All India Bank Employees Association (AIBEA), All India Bank Officer's Association (AIBOA), Bank Employees Federation of India (BEFI) and All India Bank Officers Confederation (AIBOC), stating that the members affiliated to their association/ union would observe a one day strike on 02nd September 2016 .

Impact on Bank's Operations:

We inform that, as per records, aforesaid Unions have a combined membership of around 10700 employees (approximately 20% of the total Employee Strength) in our Bank majorly, from Clerical and Sub-staff cadres.

The associations/ unions have membership spread majorly in the states of Gujarat, UP, Uttrakhand, Bihar, Jharkhand, Rajasthan, Tamilnadu, West Bengal, Chhattisgarh, Maharashtra ,Telangana, Orissa , Kerala and Delhi.

In the event of AIBEA ,AIBOA, BEFI and AIBOC proceeding on strike on 02nd September 2016 the functioning of Branches in these states will be affected.
