- 2. No tender will be received after 2.30 pm on 04/01/2019. Requests under any circumstances whatsoever will not be entertained.
- 3. The tenderer must use only the forms displayed on the bank's website to fill in the rates. (Any addition/ alteration in the text of the tender form made by the tenderer shall not be valid and would be liable of rejection).
- 4. (a) The tender form must be filled in Hindi / English and all entries must be made by hand and written in ink. The rate and amount should be in figures and words. If any of the documents is missing or unsigned, the tender may be considered invalid by the Bank Representative in its discretion.
- 4. (b) Rates should be quoted both in figures and in words in columns specified. All erasures and alterations made while filling the tender must be attested by initials of the tenderer. Overwriting of figures is not permitted and failure to comply with either of these conditions will render the tender void at the Bank's option. No advice of any change in rate or conditions after the opening of the tender will be entertained.
- 4. (c) Any tender with any of the documents not so signed will be rejected.
- 4. (d) The tender submitted on behalf of a firm shall be signed by all the partners of the firm or by a partner who has the necessary authority on behalf of the firm to enter into the proposed contract. Otherwise the tender may be rejected by the Bank.

- 5. The Bank does not bind itself to accept the highest or any tender and reserves to itself the right to accept or reject any or all the tenders, either in whole or in part, without assigning any reasons for doing so.
- 6. On receipt of intimation from the Employer of the acceptance of his/their tender, the successful tenderer shall be bound to implement the contract agreement within Fourteen days thereof, the successful tenderer shall sign the agreement in accordance with the draft agreement and the schedule of conditions but the written acceptance by the Bank of a tender will constitute a binding contract between Bank of Baroda and the person so tendering, whether such formal agreement is subsequently executed or not. The cost of necessary stamp paper for execution of the agreement shall be borne by successful tenderer.
- 7. Vendor should take the manure on daily basis. If the vendor does not collect the manure continuously for -2- days, then contract may be terminated.
- 8. The contract is initially valid for one year and it may be extended for another one year. Rate will be firm for one year and a hike of amount of 10% will be considered on extended period of contract.
- 9. Payment to be made to the Bank on daily basis.
- 10. Selected bidder should deposit an amount of ₹15,000/- as security deposit within -15-days from the date of issue of work order.
