The contract shall be for a period of one year from date of signing of the agreement and extendable upto two years based on the performance and it will be at the sole discretion of the bank, unless terminated by the Bank at its own convenience by giving a prior notice of 30 days in writing to the firms without assigning any reason(s) and without any cost(s) or compensation therefore. Tender form be downloaded from Bank's web site. Applications not received in prescribed manner will be rejected.

It is highlighted and to be noted by prospective applicants that they will be fully responsible for the manufacturer's warranty in respect of proper design, quality and workmanship.

### (B) Submission of Proposal-

The offer will be in two parts; Technical bid & Financial bid separately. Both the parts should be submitted in separate sealed covers duly super-scribed "Technical Offer for empanelment of service provider for supply of uniform accoutrements" and "Financial Offer for empanelment of service provider for supply of uniform accoutrements". The Financial Bids to be put in a separate envelope. Both the sealed envelopes should be placed in another sealed envelope super-scribed "Tender for Supply of Security Accoutrements for the Armed Guards / Watchmen of Bank of Baroda" and submit the same at the following address,

- 1. If all the envelopes are not sealed and marked as mentioned above, Bank of Baroda shall assume no responsibility for the misplacement or premature opening of the bid.
- 2. Annexure I (Technical Bid) will be opened on **13/01/2020**, **3.30 pm**. Opening of Financial Bid (Annexure II) will be intimated separately by e-mail only to technically qualified bidders.
- 3. Tender shall be valid for a period of 120 days from the date of opening of Technical Bid and shall remain binding upon the bidder.
- 4. The rates quoted are inclusive of cost of Die, materials, levies, royalties and duties etc. excluding taxes.



- 5. The rates quoted are inclusive of packing material used for sending the quantity as decided by Bank to different locations throughout India. However, courier charges are not included which would be paid extra on actual on furnishing of courier charges bill along with material invoice at the destination office of the Bank. Bank does not take any responsibility whatsoever for damage, misplace, non-delivery of item at destination. Payment would be released by Baroda Corporate Centre, Mumbai only after satisfactory delivery of the item at receiving office as per details contained in the invoice.
- 6. Bank reserves the right for any addition / deletion / alteration of materials / specifications before / after awarding the job without any compensation.
- 7. Bank reserves the right to reject any or all tenders or split the order to the others technically qualified bidders without assigning any reason thereof.

### (C) <u>DESCRIPTION OF SECURITY ACCOUTREMENTS</u>

The bank desires to procure 1000 sets of the following accourtements for its Armed Guards / Watchmen:-

- a. Brown Leather Belt with Buckle (Nickel plated) with engraved Bank's Monogram
- b. Lanyard (Maroon)
- c. Security Badge for Cap (Nickel plated) size 32 mm
- d. Thunder Whistle
- e. Scarf (terry cot with Bank Logo) (Maroon)
- f. BANK shoulder Title (Nickel Plated) Size 65 mm length and 12 mm width with a pin (2 Nos. each)
  - (Photographs of item No. a, b, c, e and f are attached for reference, all the Bank's logos must be engraved only)
- (D) The period of supply of all the items is within 01 months from the date of awarding the contract. The Contract shall be awarded after approval of design of Buckle, Cap Shoulder Badge and Scarf.

### (E) <u>REFUNDABLE SECURITY DEPOSIT</u>

Earnest Money of Rs.50,000/- by crossed DD / BC in favour of Bank of Baroda, payable in Mumbai will be deposited along with the technical bid. Earnest Money of selected Bidder will be refunded after 02 month of complete delivery of tendered items. The earnest money deposit of a vendor may be forfeited by the Bank if the vendor withdraws its bid during the bid validity period or the vendor refuses to accept and sign the contract within 1 month of issue of contract order / letter of intent for any reason.

### (F) SUBCONTRACTING:

The vendor shall not subcontract or permit anyone other than its personnel to perform any of the work, service or other performance required by it under this assignment without the prior written consent of the Bank.



### (G) Termination

Bank shall have option to terminate / cancel this RFP at any stage without any prior notice.

In following events Bank shall terminate this assignment or cancel any particular order if Vendor:

Breaches any of its obligations set forth in this assignment or any subsequent agreement and Such breach is not cured within thirty (30) Working Days after Bank gives written notice; or

- a. failure by Vendor to provide Bank, within thirty (30) Working Days, with a reasonable plan to cure such breach, which is acceptable to the Bank. Or
- b. The progress regarding execution of the contract/ services rendered by the Service Provider is not as per the prescribed time line, and found to be unsatisfactory.
- c. Supply of substandard materials/ services ;
- d. Delay in delivery / installation / commissioning of services.

Notwithstanding above, in case of change of policy or any unavoidable circumstances Bank reserve the right to terminate this assignment or any subsequent agreement and / or any particular order, in whole or in part by giving Vendor at least 90 days prior notice in writing.

### (H) Effect of termination:

If bank terminate or cancel the assignment on the default mentioned in the termination clause, in such case Bank reserves the right to get the balance contract executed by another party of its choice. In this event, the Service Provider shall be bound to make good the additional expenditure, which the Bank may have to incur to carry out bidding process for the selection of a new Vendor and for execution of the balance of the contract.

In case of bank cancel any particular order, the advance payments made by the Bank to the Vendor would necessarily have to be returned to the Bank with interest @ 15% per annum from the date of each such payment. These payments to be returned would refer to those deliverables that will have to be reversed or redone post the termination of the vendor.

### (I) Dispute Resolution

The Bank and the vendor shall make every effort to resolve amicably, by direct informal negotiation between the respective project managers / directors of the Bank and the vendor, any disagreement or dispute arising between them under or in connection with the contract.

If the Bank project manager / director and vendor project manager / director are unable to resolve the dispute after thirty days from the commencement of such informal negotiations, they shall immediately escalate the dispute to the senior authorized personnel designated by the vendor and Bank respectively.



If after thirty days from the commencement of such negotiations between the senior authorized personnel designated by the vendor and Bank, the Bank and the vendor have been unable to resolve contractual dispute amicably, either party may require that the dispute be referred for resolution through formal arbitration.

All questions, disputes or differences arising under and out of, or in connection with the contract or carrying out of the work whether during the progress of the work or after the completion and whether before or after the determination, abandonment or breach of the contract shall be referred to arbitration by a sole Arbitrator acceptable to both parties OR the number of arbitrators shall be three, with each side to the dispute being entitled to appoint one arbitrator. The two arbitrators appointed by the parties shall appoint a third arbitrator shall act as the chairman of the proceedings. Arbitration will be carried out at Mumbai. The Arbitration and Conciliation Act 1996 or any statutory modification thereof shall apply to the arbitration proceedings

Judgment upon the award may be entered by any court having jurisdiction thereof or having jurisdiction over the relevant Party or its assets.

#### (J) Governing Laws

This RFP and The subsequent contract shall be governed and construed and enforced in accordance with the laws of India. Both Parties shall agree that in respect of any dispute arising upon, over or in respect of any of the terms of this Agreement, only the courts in Mumbai shall have exclusive jurisdiction to try and adjudicate such disputes to the exclusion of all other courts.






