- 1.1 **The Bank of Baroda (BOB)**, herein called the Employer / Owner, hereby invite you to tender on item rate basis for RO System Capacity 3000 LPH (Permeate) for its NEW Administrative Office Building at Gulistan Bungalow, RC Dutta Road, Alkapuri, Vadodara.
- 1.2 The tender forms can be had from the office of **The General Manager & Head (FM & COA), Bank of Baroda, Estate Management, 1st floor, Baroda Corporate Centre, Mumbai 400 051**, alternatively tender can be down loaded from Bank's website www.bankofbaroda.co.in
- 1.3 **Submission of Tender**

The Tenders are to be submitted in three separate envelopes, each sealed and clearly identified as to envelope number and contents as indicated below. The three envelopes shall be contained in a large envelope **superscribed** "Tender for RO System for Construction of Office Building of Bank of Baroda at Gulistan Bungalow, RC Dutta Road, Alkapuri, Vadodara.
- 1.4 Your tender duly filled in, signed and sealed, should be addressed and hand delivered to **The General Manager & Head (FM & COA), Bank of Baroda, Facility Management Department , 1st floor, Baroda Corporate Centre, Mumbai 400 051** on or before **15.00 hours of 06/10/2017**.



1.5 Each Tenderer will be issued one copy of Conditions of Contract (Vol.-I), Specifications and 2 copies of Price Bid /Bill of Quantities (Vol.-II) for preparation of this Tender. Tenderers shall submit the documents in Envelope No. 1, Envelope No. 2 and Envelope No. 3 as stated below.

1.6 (i) **Envelope No. 1**

Envelope No. 1 shall contain the following:

- a) **Earnest Money Deposit** of **Rs. 14,000.00(Rs. Fourteen Thousand only)** in the form of Demand Draft / Pay Order / Bank Guarantee only in favour of Bank of Baroda drawn / issued on any Nationalised / Scheduled Bank and payable at Mumbai.
- b) The Companies registered with NSIC/MSME/KVIC are exempted from submission of EMD on submission of valid certificate of registration as per the rule of Government of India. Such companies are requested to submit the valid certificate along with the technical bid.

(ii) **Envelope No. 2**

- i. Vol. I and Vol. II along with set of the drawings duly stamped and signed on each page.
- ii. All submittals as per Clause 6 of **Information and Instructions to Tenderers**.
- iii. Any other documents as stated in tender Documents.

This envelope shall be super scribed "Envelope No. 2 - Technical Bid for RO System for Construction of Office Building of Bank of Baroda at Gulistan Bungalow, RC Dutta Road, Alkapuri, Vadodara.

(iii) **Envelope No. 3**

Envelope No. 3 shall contain Priced Bill of Quantities duly filled in and signed on each page by the Tenderer. Rate quoted in the original copy of B.O.Q. shall be considered as valid.



1.7 Late Tenders

Tenders received late on account of any reason whatsoever and telegraphic tenders will not be entertained.

1.8 Opening of Tender

The Envelope No. 1 i.e. the Technical Bid of the Tender will be opened immediately after last date and hour of submission i.e. on **06/10/2017 at 16.30** hrs or any extended date duly intimated in presence of Tenderers who wish to be present. Representatives who wish to be present during the tender opening shall carry a proper letter of authority issued by the Competent Authority of the firm / company to attend the same, without which they shall not be allowed therein.

1.9 Deleted

1.10 The Tender without EMD or valid certificate issued by NSIC/MSME/KVIC of will summarily be rejected.

1.11 No other conditions shall be accepted thereafter and the Tenderer shall give a declaration accepting all the conditions given in the Tender or Addenda / Corrigendum if any. **Tender along with any conditions is likely to be rejected.**

1.12 Evaluation of Tender

The bidders who submit the documents as required as well as other criteria as stipulated in the Tender will be qualified for opening of their Price Bid.

1.13 Validity of Tender

The Tender shall be valid for a period of 30 days, from the last date of submission of the tender. The tenders shall not be entitled during the said period of 30 days to revoke or cancel or vary the tender. In case of tenderer revoking or canceling or varying this tender, the EMD shall be forfeited.
