PRICE

SPECIAL TERMS OF THE CONTRACT

2. Completion Period : 2-3 Weeks from the Letter of Intent/

Work Order.



3. Escalation

: The prices shall remain firm and shall not subject to variation for any reason whatsoever. All rates shall be firm throughout the duration of the contract and no influences shall be permitted for any changes in any of costs or inclusions due to any reasons such as currency variations, material, transport and price fluctuations or any other reason unless expressly provided for elsewhere in this agreement.

4. Defect Liability Period (DLP)

: 24 months from the date of issuance of Virtual Completion Certificate issued by the Bank.

The Contractor shall make good at his own cost and to the satisfaction of the Bank's engineer, all defects or other faults and all damages, loss and expenses consequent thereon or incidental thereto, and such damage, loss and expenses shall be recoverable from the contractor by the Employer or may be deducted by the Employer from any money due or that becomes due to the Contractor.

In these conditions, the expression "Period of Defects Liability" shall mean the period of Defects Liability as above, calculated from the date of completion of the Works (Virtual Completion Certificate).

5. Liquidated Damages

: 1% of the Contract value per week subject to maximum of 10% of Contract value will be deducted from the bills of the vendor on account of delay in execution of the work as per the schedule mentioned in the tender/work order.

6. Payment

: Full and Final Payment shall be made only after satisfactory completion of all the works assigned to you at the aforesaid Site. No advance/interim payment shall be made by the Bank.



WARRANTY

The bidder should provide minimum 2 years warranty for the Batteries.

FREE MAINTENANCE AND DEFECT LIABILITY PERIOD

Following are the works which shall be carried out during the free maintenance period (DLP):

- Periodic inspection (preferably quarterly) for proper working of the batteries and identification of any fault/abnormality. The vendor shall also visit the site for inspection of the batteries during emergency situations or as and when required.
- Replacement of any defective part at the own cost of the Vendor. Bank will not pay any
 cost in this regard whatsoever.

RISK PURCHASE CLAUSE

In the event of failure of the SUCCESSFUL BIDDER to deliver or dispatch or provide the required services within the stipulated date/ period of the supply order/Tender, or in the event of breach of any of the terms and conditions of the Tender, the Bank will have the right to purchase the items/services from elsewhere at the risk and cost of the defaulting vendor after giving due notice to the defaulting vendor.

The cost as per Risk Purchase exercise may be recovered from the bills pending with the supplier against any other supplies/services outside this contract or even from the pending bills with any other Government Department/Ministry.

In the event of a contract being cancelled for any breach committed and the Bank effecting repurchase of supply items & services at the risk and the cost of the contractor, the Bank is not bound to accept the lower offer of Benami or allied or sister concern of the contractor.

LAW GOVERNING THE CONTRACT

- (i) This contract shall be governed by the laws of India for the time being in force. The contract shall be interpreted in accordance with these laws.
- (ii) Jurisdiction of Court: The Courts of the MUMBAI shall alone have jurisdiction to decide any dispute arising out of or in respect of the contract.

RIGHT TO REJECTION

The decision of the Bank shall be final as to the quality of the material/services and shall be binding upon the Tenderers and in case of any of the articles supplied, not being found as per specification and approved sample, shall be liable to be rejected or replaced and any expenses or losses caused to the Bank should be borne by the vendor and ensured by the vendor that articles supplied should be best in quality and free from all defects.

The acceptance of articles will be made only when the articles are inspected and found up to the standard specifications and free from all defects.

The rejected items must be removed by the tenderers from the consignee's premises within 15 days from the date of intimation about rejection at the risk and cost of the tenderers.

ARBITRATION

All disputes and difference of any kinds whatsoever arise out of or in connection with the contract whether during or after completion of contract shall be deemed to have arisen at Mumbai and only court in Mumbai shall have jurisdiction to determine the same.

Arbitration proceedings shall be held at Mumbai, India and the language of the arbitration proceedings and that of all documents and communications between the parties shall be in English or Hindi.

GENERAL CONDITIONS

In case of difference between the rates written in figures and words, the rate adopted (in words) for working out the total amount of the item in the Quotation shall be taken as correct. In all other cases the correct rate would be that which is lower.

In all cases of omissions and / or doubts or discrepancies in any item or job requirement, a reference shall be made to the General Manager, whose elucidation, elaboration or decision shall be considered as authentic and final. The contractor shall be held responsible for any errors that may occur in the work through lack of such reference and precaution.

When there is a difference between the rates in figures and in words, the rate which corresponds to the amounts worked out by the Contractor, shall be taken as correct.

When the rate quoted by the Contractor in figures and in words tallies but the amount is not worked out correctly, the rate quoted by the Contractor shall be taken as correct and not the amount.

The Employer reserves the right to accept the tender in full or in part and the tenderer shall have no claim of revision of rates or other conditions whether his tender is accepted in part or in full.

Canvassing in connection with the tender is strictly prohibited and the tender submitted by any Contractor who resorts to canvassing will be liable to rejection.

An item rate tender quoting rates in terms of "percentage below / above will be summarily rejected. On acceptance of tender, the name of the accredited representative(s) of the Contractor who would be responsible for taking instructions from the Employer shall be communicated to the Employer by the Bidder in writing.

LIQUIDATED DAMAGES FOR DELAY

1% of the Contract value per week subject to maximum of 10% of Contract value will be deducted from the bills of the vendor on account of delay in execution of the work as per the schedule mentioned in the tender/work order.

TERMINATION OF CONTRACT

Time shall be the essence of the contract. The Bank shall have the right to terminate this Contract without any notice in part or in full in any of the following cases:-

- The delivery of the material is delayed for causes not attributable to Force Majeure after the Scheduled date of delivery. The Seller is declared bankrupt or becomes insolvent.
- ➤ The delivery of material is delayed due to causes of Force Majeure by more than 60 days.
