ePayment of Customs Duty

General

- Under ePayment of Customs duty, the evaluated customs duty challan is populated on customs website www.icegate.gov.in and same can be paid by customer online using internet banking facility.
- As soon as Customs duty is paid online by the importer the information is updated at customs site instantly.
- Customer gets a cyber receipt for ePayment of Customs duty.

- Customer to visit the Baroda Connect website – <http://www.bobibanking.com>
- Download Application form for eBanking for Retail or Corporate User
- This form is also available at the BoB CBS Branches
- Customer to fill the form and submit along with relevant documents to a BoB CBS Branch
- BoB Branch validates the customer information
- BoB Dispatches the User ID to Customers communication address
- Customer to collect the PW from the BoB Branch
- Customer is enabled for Baroda Connect Services after receiving PW

- Visit to www.icegate.gov.in
- Select 'Membership and Partnership Registration Form'
- Fill all the relevant details including IEC code
- Click on 'SUBMIT'

For Customer registered at ICEGATE

- Login to www.icegate.gov.in
- Select services and click on E-Payment
- Click on Login under registered user
- Login with ICEGATE userid and password
- Select EPayment, all Your pending challans will be shown
- Select challan and click on 'PAY'
- Select Bank Of Baroda from list of Banks
- Select Retail/Corporate and login with Baroda Connect Userid and signon password
- Verify the details of challan and select account to be debited
- Click on 'PAY' and give Baroda Connect userid and transaction Password
- On Successful payment, Printable/savable Cyber receipt is shown
- **Always click on Link provided below cyber receipt to complete the transaction**
- Unless you click the said link the details of the payments made will not be updated at Customs site
- Successful payment message will be shown by ICEGATE

For Customer not registered at ICEGATE

- Login to www.icegate.gov.in
- Select Service and click on ePayments
- Give your IEC code under unregistered user and click on 'Find'
- All Your pending challans will be shown
- Select challan and click on 'PAY'
- Select Bank Of Baroda from list of Banks
- Select Retail/Corporate and login with Baroda Connect Userid and signon password
- Verify the details of challan and select account to be debited
- Click on 'PAY' and give Baroda Connect userid and transaction Password
- On Successful payment, Printable/savable Cyber receipt is shown
- **Always click on Link provided below cyber receipt to complete the transaction**
- Unless you click the said link the details of the payments made will not be updated at Customs site
- Successful payment message will be shown by ICEGATE
