- " Select Retail or Corporate User

The dealer will be provided a link for viewing the Challan details, %Generate Challan+ on clicking which, the user can view and print the complete Challan.

A 20 digit Challan Identification Number (CIN) is displayed. This is the unique number generated at bank's end to uniquely identify all Challan payments. This number should be carefully preserved. The CIN will also be printed in the Challan which is generated at the bank's site.

Once the payment is done, after some time duration, the dealer will be taken back to the CTD web portal, where the unique bank reference number and CIN number are displayed
