Re: Dearness Relief payable to STAFF PENSIONERS i. e. Pension to Ex-Employees of Bank of Baroda for the months from August 2022 to January 2023.

In terms of Regulation 37 of Bank of Baroda (Employees') Pension Regulations, 1995, Dearness Relief is payable to pensioners in accordance with the rates specified in Appendix II of the said Regulations. The All India Average Consumer Price Index numbers for industrial workers (Base 1960=100) for the quarter ended June 2022 are as follows:

April 2022 - 8394.82 May 2022 - 8480.28 June 2022 - 8493.43

Accordingly, the rates of Dearness Relief payable to retired Bank employees drawing pension will stand revised for the months from August 2022 to January 2023 as per Annexure.

Pending amendments to Regulation 37 of Bank of Baroda (Employees') Pension Regulations, 1995, dearness relief is payable to pensioners on ad-hoc basis which is as under:
